You may be eligible to receive an 8% rebate on your electricity bill effective January 1, 2017 under the *Ontario Rebate for Electricity Consumers Act, 2016* ("ORECA"). If your account meets any of the eligibility criteria below, please check off all boxes that apply, sign and date the form. Once completed, please return it to ENWIN Utilities Ltd. (hereafter, "ENWIN") by mail, email at keyaccounts@enwin.com, or by fax to: (519) 255-7423.

If you qualify for the rebate, we will credit your account (as applicable) for electricity consumption effective from January 1, 2017 or for a maximum of two years prior to the date you provide us with the completed self-declaration form, if submitted after January 1, 2019.

Eligibility for the 8% rebate

To be eligible to receive the 8% rebate on your electricity bill, you must qualify under at least ONE of the following criteria:

(Please check all that apply to your account)

- The consumer has a demand for electricity of 50 kilowatts or less;
- Annual consumption of 250,000 kilowatt hours of electricity or less;
- You carry on a business that is a farming business for the purposes of the Farm Registration and Farm Organizations Funding Act, 1993, and you hold a valid registration number assigned under that Act or your obligation to file a farming business registration form was waived pursuant to an order made under subsection 22 (6) of that Act;

 - or,
 - Waiver order number and date: _____.

- Your account relates to one of the following:
 - (i) a dwelling,
 - (ii) a property, within the meaning of the *Condominium Act, 1998*,
 - (iii) a residential complex, within the meaning of subsection 2 (1) of the *Residential Tenancies Act, 2006*, without regard to section 5 of that Act, or
 - (iv) a property that includes one or more housing units and that is owned or leased by a co-operative within the meaning of the *Co-operative Corporations Act*,

- Your account includes one or more non-traditional residential units, such as a hotel/motel or a post-secondary student residence, where the unit must be the full-time, permanent residence of the occupant. Also, the occupant pays rent and has the right of exclusive possession of the unit. Exclusive possession means that the occupant cannot be evicted without some sort of formal process.

ENWIN will use the information collected on this form for the purposes of confirming your eligibility for the 8% rebate to your bill and for auditing purposes. Interest may be charged on any repayment monies owed in accordance with ENWIN's policies.
