Does Your Account Qualify for Regulated Price Plan (RPP) Pricing?

You qualify for RPP Pricing if you meet **one** of the following conditions:

- 1. Farming Business
 - You operate a farming business under the Farm Registration and Farm
 Organizations Funding Act, 1993 and hold a valid Farm Business Registration
 Number, or your obligation to register has been waived under subsection 22(6) of
 the Act.
- 2. Your account is for a:
 - Dwelling
 - Property under the Condominium Act, 1998
 - Residential complex under the Residential Tenancies Act, 2006
 - Property with one or more housing units owned or leased by a co-operative under the Co-operative Corporations Act

If your account qualifies:

- Complete the information below.
- For multiple qualified accounts, submit a separate page for each.
- Do not include units that are separately metered or billed.

Acknowledgement of Terms

By submitting this form, you acknowledge:

- Under the Ontario Energy Board Act and O. Reg. 95/05, you will automatically be
 placed in the prescribed RPP fixed rate class unless you meet the exemption
 criteria.
- If you do not meet the exemption criteria, your account will be switched to RPP at the start of your next billing cycle.

To remain outside the RPP:

- 1. **Sign a contract** with an electricity retailer for commodity supply. (If you already have one, this declaration does not change your rate.)
- 2. **Elect to be placed** on the Ontario Electricity Market Price by submitting a written request to ENWIN **if** your service address has an interval meter.
 - Unsure if you have an interval meter? Contact ENWIN for information or installation options.

Note: Rate changes take effect from the next billing date onward.
